ENGINEER'S REPORT GLOUCESTER TOWNSHIP M.U.A.

January 19, 2023

- On December 5th, 2022 a gravity main issue was reported along Broadacres Drive at Little Gloucester Road. The Authority identified sections of collapsed 14" gravity main at approximately 14 feet deep. R.D. Zeuli, Inc. was contacted to complete the repairs. Gravity pipe was replaced in several locations and a new doghouse manhole was installed for future maintenance. I have recommended payment in the amount of \$241,977.23 to R.D. Zeuli, Inc. for the services provided.
- On December 19th, 2022 a sewer manhole issue was reported along Sicklerville Road. The Authority identified a deteriorated sewer frame and cover located within the roadway. R.D. Zeuli, Inc. was contacted to complete the repairs. A new frame and cover were installed, and final restoration was provided for the repair. I have recommended payment in the amount of \$4,729.63 to R.D. Zeuli, Inc. for the services provided.
- 3. On December 22nd, 2022 my office submitted the required NJPDES stormwater permit application for the Authority's Compost facility. On January 11th, the permit was deemed administratively complete and has been forwarded to the Bureau of NJPDES Stormwater Permitting & Water Quality Management for technical review and processing.
- On December 22nd, 2022 my office submitted the renewal application for the Authority's Recycling Center General Approval for Class C Materials.
- 5. On January 6th, the Authority completed final restoration for sewer repairs on Lower Landing Road in accordance with Camden County Road Opening permit requirements. I have recommended payment in the amount of \$5,423.66 to R.D. Zeuli, Inc. for the services provided. Final restoration for sewer repairs on Orr Road is being scheduled.
